For the three months ended March 31, 2023, the Registrant had a net loss of \$186,676, which consists of general and administrative expenses of \$1,959,668 and provision for income taxes of \$458,011, offset by interest earned on investments held in the trust account of \$2,231,003. For the three months ended March 31, 2022, the Registrant had a net loss of \$226,114, which consists of general and administrative expenses of \$289,327, offset by interest earned on investments held in the trust account of \$63,213. The amounts reported above are still under review by the Registrant's independent registered public accounting firm and accounting staff and may differ once reported in the Form 10-Q to be filed by the Registrant.
